PUBLIC COMMENT ON ANY AGENDA ITEM:

Baldemar Aviles presented a letter to the Board of Trustees. Topic of letter is health insurance. Baldemar Aviles stated the employees at Calvary Cemetery were not informed in a timely manner regarding insurance change. After a short discussion regarding if Baldemar attended meetings when the change was discussed and the cost of remaining on the current insurance it was stated that action could not be taken due to not being placed on the agenda. Trustee Jim Harper stated the Board will review the letter submitted.

CONSENT CALENDAR:

<u>DISCUSSION/REPORT REGARDING MADERA COUNTY TRANSFER PAYROLL & PERS EFT ERRORS:</u>

District Manager Belva Bare stated Madera County Treasury office had an issue regarding transferring of funds for payroll and PERS EFT transfer. The County had closed all direct withdrawals and did not inform us. When the error was caught the County covered all charges and payroll went out.

<u>DISCUSSION/REPORT/APPROVAL REGARDING GLASS FRONT NICHES</u> CALVARY CEMETERY:

District Manager Belva Bare stated the committee of Maurice Cappelluti, Jim Harper, John Anderson and I met with Larry Moore at the Calvary Cemetery for discussion of the placement of glass front niches. A short discussion of extending the existing building and cost was had. Trustee Jim Harper made a motion to move forward with the installation of the glass front niches. Trustee Candy Talley seconded the motion. All Board Members were in favor.

<u>DISCUSSION/REPORT/APPROVAL OAKHILL NICHES COMPLETION DATE AND</u> COSTS:

District Manager Belva Bare stated things are going well. A short discussion regarding the price factor of the new niches was had. Trustee Jim Harper made a motion to accept the cost of \$1,575.00 for a single niche complete entombment. Trustee Candy Talley seconded the motion. All Board Members were in favor, Trustee David Nemeth abstained due to conflict of purchase of niche.

DISCUSSION/REPORT IF NEEDED ON OPERATIONS OF M.C.D. CEMETERIES:

A short discussion on regarding marker replacement was had. District Manager Belva Bare stated that Superintendent Ronnie Ramirez took on the project to replace old telephone lines working with AT&T to install internet cable. All the employees took this as a group project.

<u>DISCUSSION/REPORT/APPROVAL REGARDING PROPERTY ADJACENT TO</u> OAKHILL CEMETERY:

District Manager Belva Bare stated the Bell property is for sale, the property boarders the Oakhill Cemetery. Trustee David Nemeth gave a presentation. Trustee Nemeth stated this is 1.068 acres; the house was built in 1959 and is not in great shape. It does have a two car garage for storage. It has a producing well but we are not sure how much it is producing. Trustee Nemeth stated if we acquired this property we would have another access, storage and control of the area. Trustee Nemeth stated our value is in the lot. After a short discussion it was decided to wait and continue this item on the agenda for future discussion.

DISCUSSION/REPORT/APPROVAL OF CALVARY WELL REPAIR:

District Manager Belva Bare asked Operations Manager John Anderson to present to the Board the current status of the Calvary Well. Operations Manager John Anderson stated Jack Van Loon stated the pump is sitting on the sand. Jack Van Loon recommends Woolley Well Drill. We are hoping to use the existing casing. John stated we are looking at a cost of \$24,027.00 Trustee Jim Harper made a motion to move forward with this item. Trustee Candy Talley 2nd the motion. All Board Members were in favor.

District Manager Belva Bare presented to the Board a Surveillance Policy. After a short discussion Trustee David Nemeth made a motion to accept the Policy as written. District Manager Belva Bare stated we will be pulling the front bench for replacement at the Calvary Cemetery. A discussion regarding replacing the bench with engraving of appreciation of the employees of Madera Cemetery District. Trustee Candy Talley made a motion for engraving on the new bench area in appreciation of the Madera Cemetery Employees. Trustee David Nemeth seconded the motion. All Board Members were in favor.

District Manager Belva Bare stated in 2019 a discussion regarding dissolving working on Halloween night. Belva stated there is no policy on employees working this holiday.
