#### **CALL TO ORDER:**

#### **CONSENT CALENDAR:**

Chairperson Lois Betty stated a few corrections are needed on the Minutes. Chairperson Lois Betty stated the only time the Board is polled is when a Policy is discussed and acted on. Chairperson Lois Betty questioned whether there was a scheduled change for location of the next Board Meeting. ### <u>DISCUSSION/REPORT/APPROVAL OF PLACEMENT/DESIGN OF NICHE</u> PROJECT OAKHILL CEMETERY:

District Manager Belva Bare stated we have been working with Jimmy Pinocchio Engineering regarding our Niche Project. The meeting location was changed to view niche placement on the grounds. After a short discussion on a safety wall, position of the niches, and a gazebo area, the board decided to place the niches laterally with the existing ones.

## <u>DISCUSSION/REPORT/APPROVAL ON SPEAKING ENGAGEMENT FOR</u> <u>OAKHURST ROTARY:</u>

District Manager Belva Bare stated the speaking engagement for Rotary went well. This was a large group, information was given regarding Oakhill Cemetery, preneed options and development of the new property. Trustee David Nemeth stated it was a good presentation. Chairperson Lois Betty asked about the new property being included as a historical site. Trustee David Nemeth stated he would contact Jones & Snyder regarding questions.

### <u>DISCUSSION/REPORT/APPROVAL CHANGING OF CREDIT CARD VENDOR</u> FROM PAYGOV.NET TO GOVPAY.NET:

District Manager Belva Bare stated the vendor for Govpay Credit Card Company gave a presentation to Madera Cemetery District. Our current credit card company PayGov charges 3.0-3.95% to the families using a credit card to pay for their services. Govpay would only charge a 2.25% fee to the customers and eventually we can even use our Website to make payments. Belva stated this is of no benefit to us, but helps the families. Trustee Candy Talley made a motion to change from PayGov to Govpay. Trustee Maurice Cappelluti seconded the motion. All Board Members in favor.

#### DISCUSSION/REPORT/APPROVAL OF DISCRIMINATION INVESTIGATION:

Chairperson Lois Betty stated this will be tabled until next meeting after the review of the report.

## <u>DISCUSSION/REPORT/APPROVAL OF VARIABLE DRIVE PURCHASE FOR</u> CALVARY WELL:

District Manager Belva Bare stated Operations Manager has brought it to her attention regarding a pressure problem we are having at the Calvary Cemetery. Operations Manager John Anderson stated we have a variable drive for the Arbor Vitae Cemetery. Since the placement of this drive the well has been doing well. This drive keeps the pressure needed to run efficiently and constant. John stated the cost is \$8,574.86. After a short discussion it was decided to take this item out of maintenance of equipment. Trustee David Nemeth made a motion to purchase the variable drive, the cost will come from maintenance of equipment. Trustee Candy Talley seconded the motion.

## <u>DECUSSION/REPORT ON SUPERINTENDENT FOR CALVARY CEMETERY & NEW HIRE:</u>

District Manager Belva Bare stated, one interview has been completed for the potential Superintendent, with another pending regarding this position. We have a new hire for Oakhill Cemetery. He will begin on October  $1^{\rm st}$ , 2019

## <u>DISCUSSION/REPORT/APPROVAL OF WREATHS ACROSS AMERICA FOR</u> <u>ARBOR VITAE CEMETERY:</u>

District Manager Belva Bare stated this is an FFA sponsored item. They will be here at the next Board Meeting for a presentation. Trustee David Nemeth made a motion to approve a FFA sponsored placement of Wreaths Across America at the Arbor Vitae Cemetery. Trustee Candy Talley seconded the motion. All Board in favor.

# <u>DISCUSSION/REPORT ON AMERICAN CEMETERY EXCELLENCE AWARD "ACE"</u> 2019, MCD ONE OF THREE FINALISTS FOR THE UNITED STATES:

Trustee Candy Talley asked how we were nominated for this. District Manager Belva Bare stated she has submitted our Cemetery information to American Cemetery Magazine. They contacted me to inform us that we were in the top three finalists. The interviewee stated they had never had a Public Agency submit information. It is an honor just to be in the top three in the Nation.

## <u>DISCUSSION/REPORT/APPROVAL OF RESOLUTION TO REDUCE RETIREES</u> HEALTH BENEFITS DATED JANUARY 1<sup>ST</sup>, 2020:

District Manager Belva Bare stated the information for the Resolution is completed. The Resolution was present to Chairperson Lois Betty for signature. District Manager Belva Bare stated this Resolution will go into effect on January 1st, 2020. A letter will be sent to the retirees explaining the max benefit will now be \$225.00. Trustee Candy Talley made a motion to accept the Resolution. Trustee Maurice Cappelluti seconded the motion. All Board Members were in favor.

District Manager Belva Bare stated we continue to be down in our total count. A few areas have increase. Mosquito Vector is very proactive along with our employees

Trustee David Nemeth stated he has had several conversations with Sandra Wheeler. David stated Stifel Investments seems to have more bond choices than Wells Fargo. Chairperson Lois Betty asked if this will cost the District to move from Wells Fargo to Stifel Investments. Trustee David Nemeth stated you can do a transfer where you move from one company to another. Trustee David Nemeth stated Sandra will manage the account. The rate she is charging is a very low amount. Trustee David Nemeth recommends going with Sandra Wheeler Stifel Investments. David stated we own the bonds at Wells Fargo it will not cost us. Trustee Candy Talley made a motion to move to Stifel Investments with Sandra Wheeler. Trustee Maurice Cappelluti seconded the motion. All Board was in favor. Chairperson Lois Betty and Trustee David Nemeth to sign transfer.
